

**BUFFALO FISCAL STABILITY AUTHORITY  
RESOLUTION NO. 25-30  
HONORING MAYOR CHRISTOPHER P. SCANLON**

WHEREAS, on July 3, 2003, the New York State Governor signed into law Chapter 122 of the Laws of 2003, known as the Buffalo Fiscal Stability Authority Act, which created the Buffalo Fiscal Stability Authority to assist in the restoration of fiscal stability in the City of Buffalo and within its covered organizations; and

WHEREAS, Christopher P. Scanlon was elected to the City of Buffalo Common Council in May 2012, representing the South District through October 2024, and was elected Council President by his colleagues in January 2025; and

WHEREAS, on October 15, 2025, Christopher P. Scanlon assumed the role of acting mayor after the resignation of Mayor Byron W. Brown, and was officially sworn in as the 63<sup>rd</sup> Mayor of the City of Buffalo on November 19, 2024; and

WHEREAS, Mayor Scanlon endeavored to work collaboratively with stakeholders, including members of government and residents and businesses within the City, having championed legislation to protect public health and safety, increase access to affordable housing, strengthen neighborhoods, support small businesses, and promote economic development opportunities throughout the City of Buffalo; and

WHEREAS, during his tenure Mayor Scanlon served as a director of the Buffalo Fiscal Stability Authority and oversaw the adoption of an annual budget and four-year financial plan, taking significant steps towards restoring fiscal stability to the City and its covered organization; and

WHEREAS, Mayor Scanlon has been unwavering in his efforts to improve the quality of life for all the City of Buffalo's residents; and

WHEREAS, Mayor Scanlon has been tireless in his efforts to advance the mission of the Buffalo Fiscal Stability Authority to restore long-term fiscal stability to the City of Buffalo and its covered organizations; and

WHEREAS, Mayor Scanlon's innumerable contributions to the City of Buffalo will endure for generations.

NOW THEREFORE BE IT RESOLVED that the Buffalo Fiscal Stability Authority does hereby honor and appreciate Christopher P. Scanlon for his outstanding contributions to the Buffalo Fiscal Stability Authority, the City of Buffalo and its residents, and the Western New York community.

This Resolution shall take effect immediately.
