

**BUFFALO FISCAL STABILITY AUTHORITY
RESOLUTION NO. 25-31
HONORING CITY OF BUFFALO COMMISSIONER OF ADMINISTRATION, FINANCE, POLICY,
AND URBAN AFFAIRS RAYMOUR P. NOSWORTHY**

WHEREAS, on July 3, 2003, the New York State Governor signed into law Chapter 122 of the Laws of 2003, known as the Buffalo Fiscal Stability Authority Act, which created the Buffalo Fiscal Stability Authority to assist in the restoration of fiscal stability in the City of Buffalo and within its covered organizations; and

WHEREAS, Christopher P. Scanlon was sworn in as the City of Buffalo's 63rd mayor on November 19, 2024; and

WHEREAS, Mayor Scanlon appointed Raymour P. Nosworthy as the City of Buffalo Commissioner of Administration, Finance, Policy, and Urban Affairs, with Mr. Nosworthy being sworn in on March 12, 2025; and

WHEREAS, Mr. Nosworthy began his career in public sector as an intern for the City of Buffalo Department of Community Services and Youth, and has served in various roles including assistant commissioner of public works and management analyst; and

WHEREAS, his dedication to the City of Buffalo is clearly demonstrated by his public sector work at the City of Buffalo having served with distinction over his career; and

WHEREAS, Mr. Nosworthy's distinguished career and extensive financial budgeting and management experience, including having served as the Director of Administration and Finance under Mayor Byron B. Brown, provided an immeasurable asset in the performance of his duties as Commissioner; and

WHEREAS, Mr. Nosworthy was designated to represent Mayor Christopher P. Scanlon at meetings of the Buffalo Fiscal Stability Authority; and

WHEREAS, Mr. Nosworthy worked diligently with the Buffalo Fiscal Stability Authority to develop a collaborative approach to address the financial challenges facing the City of Buffalo; and

WHEREAS, Mr. Nosworthy's contributions to the Buffalo Fiscal Stability Authority, the City of Buffalo, and the community will endure and positively impact future generations.

NOW THEREFORE BE IT RESOLVED that the Buffalo Fiscal Stability Authority does hereby honor and appreciate Raymour P. Nosworthy for his outstanding contributions to the Buffalo Fiscal Stability Authority, to the City of Buffalo and its residents, and to the Western New York community.
